



ACEP-Supported Bill Introduced to Stop Medicare Payment Cuts, Provide Inflationary Update

On October 29, the ACEP-supported bipartisan "Medicare Patient Access and Practice Stabilization Act" (H.R. 10073) was introduced in the House of Representatives by congressional physician champions and physician allies. Now, it needs emergency physician support to help enact it into law.

This bill fully addresses the impending 2.8% Medicare Physician Fee Schedule (PFS) cuts scheduled to go into effect on January 1, 2025, and goes further to provide a temporary update to the PFS via a one-year inflationary update of half the 2025 Medicare Economic Index (MEI), a proposal similar to recommendations that the Medicare Payment Advisory Commission (MedPAC) recently shared with Congress.

ACEP continues to prioritize long-term, sustainable physician payment reform as a key pillar of our federal advocacy efforts.

This bill is a vital stopgap to fully prevent the imminent cuts facing emergency physicians at year-end, establish an important precedent of reflecting inflationary pressures in the Medicare physician payment system, and to provide the physi-

cian community and Congress additional time to collaborate on long-term physician payment reform.

ACEP and 130 organizations representing physicians, health care providers, hospitals, and other organizations support passing this bill into law. Read the press release from the bill sponsors here.

Legislative Update

Fall is here as is evidenced by: the roar of fans in high school football stadiums; the dramatic increase of traffic on the roads; the realization that the strange noise and smell in your house is the heater coming back on after over a half year's reprieve; Christmas music on the radio; and, the ability to see your local intersections again as the political signs (at least most of them) have been removed now that the 2024 general election is finally over.

In Arizona, our very own AzCEP Board Member (and former state legislator) Amish Shah was the victor in a hard fought, six-way Democratic primary in July but lost in the general election to incumbent David Schweikert.

In Arizona at the state level, the results of the 2024 general election is a 33-27 Republican majority in the Arizona State House (31R-29D before the election) and a 17-13 Republican majority in the Arizona State Senate ((16R-14D before the election). The Governor was not on the ballot as her term runs to the 2026 general election.

With the election comes the legislative appointment of new leadership and Health and Human Resources Committee chairs. In the Senate, Senator Warren Petersen remains the Senate President with newly elected Carine Werner now chairing the HHR committee with past chair TJ Shope as her Vice Chair.

In the House, Representative Montenegro (former House Health Chair) will be the new Speaker of the House with Representative Selina Bliss, who is a nurse from Prescott, appointed as the new House Health and Human Resources Chair. Representative Ralph Heap will be her Vice Chair and he is a surgeon from the East Valley.

The legislature goes back into Session on Monday, January 13th. Available money to spend on state programs will once again be tight and we expect proposed legislation for 2025 to include scope of practice and insurance issues along with other health-related issues that will arise once the legislative session has started.

A reminder that our ED Doc Day at the Capitol is scheduled for Wednesday, March 5th. This event is of vital importance to our membership as we use this opportunity to meet with and educate the legislators on crucial issues affecting our community.
